

MEMORANDUM of the movement **Coalition for Life**

Analysis of the existing situation

Situation and trends in the Slovenian and the world society for which we have been setting up

Global measures, that had been imposed by the UN and WHO on all UN member states from March 2020 onwards, have revealed the most violent plan in the history of the humankind to enslave the majority of it. The strategic plans of the globalists (Rockefeller, Bill&Melinda Gates 2010, Agenda21, The Great Reset Davos 2020, Event201,...) are revealing in detail the intentions of elimination of the role of the democratic decision-making of the people and also on the level of the national states. Strategies of the global corporations are setting up the technocratic transhumanism as the new paradigm of the global governance which means the destruction of humanism, constitutional democracies and welfare of the majority of people. Concentrated global capital has been accelerating the robbing, poisoning and killing of people all over the world. Also in Slovenia. Differences in wealth and influence on the decision-making have globally reached the culmination. In the framework of the system, which has been functioning for decades, it is not possible to find the solution to set up decent living conditions for the majority of the citizens. Slovenia has lost its sovereignty, which was gained at least formally, when getting its independence, but the networks of formal and informal power and mass media are acting in the interest of the globalists. The current system of decision-making is not acceptable for the citizens of Slovenia because it leads to total dependence of the decision-making in Slovenia on the foreign networks of power and most citizens do not have a possibility to bring forward their life interests when political decisions are taken.

Mission

The Coalition for Life is the core entity aimed at raising awareness and mobilising the citizens of Slovenia to fight for survival and setting up the conditions for a decent, quality life within the harmoniously functioning national state as the constitutional democracy. We cooperate with all who are ready to support the vision and goals of the Coalition for Life: individuals, associations, movements or political parties (only those which are not financially or otherwise influenced by the corporations who follow the globalistic goals of overtaking the natural and human resources or decision-making about them).

Vision

Our long-term view of the Slovenian society

We want our Slovenia as a sovereign national state, governed for the benefit of its citizens, a harmoniously functioning, healthy society which will enable all its citizens to develop their personal potentials alongside with the optimal and regenerative use of all national resources. Citizens and a society are healthy when constructively supported by state institutions with the zero tolerance for corruption. Preserving and enabling of the national cultural identity and the historical tradition of the Slovenian people who had been developing gradually into the nation through its 1,400-year history. In friendly, cooperative, mutual interest based international alliances.

Values

Our paradigm orientations, priorities

- Humanism as an alternative to transhumanism

Goals

What we want to achieve

- Establish the state governance for the benefit of citizens.
- Moderate annual growth of GDP, with the higher growth of its good components and the decreasing of the bad ones.
- Vitality of the nation by supporting the citizens and families in all life situations with their basic life needs and their development ambitions.
- Shaping the development policy of Slovenia with the regenerative attitude towards all of its resources, eliminating the destructive extractivism.
- Monetary sovereignty with the central bank as a part of the national political space.
- Bank system as a cheap, quality infrastructure for a healthy society, economy and non-commercial public services.
- Technological development conditioned by a positive effect on living conditions and work conditions of the citizens.
- Fiscal sovereignty of the national state.
- Food/nutrition and energy self-sufficiency.
- Exit from NATO.
- Contractual relationship with the EU, conditioned by the national interests of Slovenia.

Strategies

Ways that we will use for transition from the existing state into the planned one, taking into account the values set.

- Health of the citizens and institutions will be reached by action on causes of the conditions and processes.
- Establishment of the new institutions and positive motivational systems which will actually enable the implementation of citizens' will and the independence of science.
- Constitutional referendum to accept the foundations of the new system of the state governance.
- Use of all forms of communication with the emphasis of the inter-personal ones.

- Establishment of synergies of action of different citizen groups which support the intentions of preserving the life-supporting systems on all levels.
- We will encourage the home-grown healthy food and formation of the vertical connection with the processing and trade, with the emphasis on co-operatives and family farms.
- We will achieve energy self-sufficiency by reducing the energy content of the industrial output of goods and services, with the nationally optimal, cheap and modern, integrated public transport system which will also connect border areas of the state into the national space.
- We will establish a better quality and humanized educational system, with the coordinated and meaningful connection of the natural sciences and humanities contents. Budgetary financing of only public schools, free of charge to pupils (primary and secondary schools) and students.
- We will support the transfer of freight transport to the upgraded railways.
- We will pay a special attention to the forest-wood processing vertical, with a regenerative attitude towards the forests, co-natural forestry, increasing the volume of the forest silvicultural works and improvement of the forest health, optimal use of the wood mass for the higher stages of processing at domestic processing plants. This will be the basis for the increase and renewal of the housing stock.

Tactics

Specific individual activities and methods.

- The group will be constituted in a mutually harmonised and most effective way.
- On the basic level, the Coalition for Life will be open to all citizens, but it will keep its commitment to the Memorandum by creating different levels of cooperation.
- Political parties are a transitional form, in the beginning very important, the emphasis is on the orientation towards the citizens' interests in the state governance institutions.
